making for improved administration ability and efficiency. We also have the Airtable database being used for the first time across the entire club, joining Team App as our club internal communication software.

# **Board Treasurers Report**

## Good evening members

Attached are two reports, the Profit & Loss and Balance Sheet as at the end of October 2022, when EHI's financial year ends.

We were back to near-normal this year with a full winter season. Some refunds from last year were applied to membership fees.

For the year the club made a profit of \$75k unaudited. Although this seems a lot, it includes \$20k of unpaid fees and sponsorship which should come through in the next month. It also includes an \$11k grant from the Dept of Industry to help with 'Covid Year' expenses.

Other items to call out, income from EFCSC was received of \$13k. In addition, a capital works grant of \$5.6k was received from EFCSC reimbursing costs paid. We thank our largest sponsor the EFCSC for this significant contribution.

We also thank Wilcon for their very generous sponsorship in 2022 and all our other sponsors.

The club set up a new members database this year using AirTable which has been a great help in tracking teams, costs, fees, offsetting coaching and umpiring, invoicing and ground hire.

The club did have the usual hockey related costs to bear in 2022. This included ground hire, coaching costs and so on. The club also paid \$9k in interest charges on our loans (grounds). The club's balance sheet remains strong.

The last audit performed on our accounts was for the Oct 2019 year. We have engaged Nick Burne to audit the 2022 financial accounts and also to audit/review the 2020 and 2021 'Covid years'. We expect this review to be completed early in the new year.

In conclusion, the 2022 year was a good year for the club, with a strong foundation to continue into the 2023 year.

Report on the Financial Report

I have reviewed the accompanying financial report of Essendon Hockey Incorporated (hereafter the Association) which comprises the Balance Sheet as at 31 October 2021, the Income Statement, the Statement of Changes in Equity and Statement of Cash Flows for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information, and the Committee's Report.

#### Auditor's Responsibility

My responsibility is to express a conclusion on the financial report based on my review. I have conducted my review in accordance with Auditing Standard on Review Engagements ASRE 2415 Review of a Financial Report: Company Limited by Guarantee, in order to state whether, on the basis of the procedures described, anything has come to my attention that causes me to believe that the financial report is not presented fairly, in all material respects, in accordance with the Associations Incorporation Reform Act 2012 including giving a true and fair view of the Association's financial position as at 31 October 2021 and its performance for the year ended on that date and complying with the Australian Accounting Standards. ASRE 2015 requires that I comply with the ethical requirements relevant to the review of the financial report.

A review of the financial report consists of making enquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Australian Auditing Standards and consequently does not enable me to obtain assurance that I would become aware of all significant matters that might be identified in an audit. Accordingly, I do not express an audit opinion.

In conducting my review, I have complied with the independence requirements of the Australian professional ethical pronouncements.
